Provided early childhood development, preschool, and adult learning programs to 373 children, youths, and families. These individuals, residents of communities throughout the Washington, DC metropolitan area, were served at the organization's two centers in Northern Virginia. Seventy-four percent of those served were children enrolled in the organization's early childhood development and preschool programs and 26% were teens and adults enrolled in the organization's adult learning program. Sixty-four percent of those served were financially low-resourced; 78% were racial and ethnic minorities.

4b (Code:) (Expenses \$ 310,168. including grants of \$) (Revenue \$ 167,620.) The Early Childhood Learning Institute (ECLI) promotes employment and career advancement in the early childhood development field through professional certifications and college credits. Ninety-six teens and adults were enrolled in the ECLI.
